His main surveying and consultancy experience is in the field of collision investigations; liquefaction of solid bulk cargoes; solid bulk cargo issues and investigations; towing, including double towage of dumb barges; grounding investigations; hold cleaning disputes; unsafe port disputes; charter party disputes including speed and consumption performance claims; cargo damage; hull fouling and paint condition; personal injury; piracy issues; container vessels; and offshore vessels and oil rigs.
