Charles Bliault has an Extra Master Mariner's Certificate. He joined Brookes Bell in 1983, was a partner from 1994 to 2009, and is now a Consultant.

His main area of surveying experience is with regard to dry cargoes, that is: dry bulk and bagged commodities; steel products; containers; ro-ro items; fruit and other refrigerated items; forest products and general cargoes. His specialist knowledge and activities are with regard to:-

- a. The carriage of, damage sustained by, and discharge of, bulk cargoes such as coal, grain and animal feeds (seed cake) and how they become damaged, particularly by heat or by water.
  - b. The carriage of, and damage sustained by, steel products.

- c. The securing of general and project cargo items and the movement and collapse of stowages.

He also has knowledge of the various hatch cover arrangements necessary for the investigation of water ingress.

His second area of specialist activity is with regard to investigations in connection with a wide range of nautical matters including safe port/berth disputes, groundings and sinkings. Other incidents investigated have included hull damage resulting from collisions or contacts with other vessels or structures, and damage to cargoes from fires and explosions on board. Some investigations have involved general average.

He has also undertaken investigations in connection with stevedore damage, condition of hatch covers and cargo gear, personal injury disputes and fishing vessel accidents, ventilation systems in holds and the ventilation of cargo. Groundings have involved salvage operations and on a number of occasions he has acted as Special Casualty Representative (SCR) where the SCOPIC Clause was invoked.

He has prepared technical reports for, and has given expert witness and witness of fact testimony at, arbitrations in the United Kingdom and the United States of America, Deemster's Court in the Isle of Man, Magistrates' Court in India, and local Judicial Court in Norway and The Netherlands.

Before becoming a marine surveyor, Charles Bliault was at sea over a thirteen-year period serving on refrigerated cargo liners, bulk carriers, refrigerated fruit carriers and container vessels in all ranks from cadet to chief officer.
